



MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is entered through mail communication based on mutual organisational interests, dated 11th August, 2021.

Between NOVOTEL KOLKATA HOTELS AND RESIDENCES & NIPS Hotel Management

A: PREAMBLE

Both parties feel that collaboration between NOVOTEL KOLKATA HOTELS AND RESIDENCES & NIPS Hotel Management will enhance the strength in organisational relationship and add value towards mutual interests.

The parties therefore agree on the objective of creating an institutional framework for enriching endeavors in mutually agreed fields of training and placements with the following broad objectives and scope:

B: Objectives & Scope:

Objectives

1. The current agreement seeks to establish strong cooperation between NOVOTEL KOLKATA HOTELS AND RESIDENCES & NIPS Hotel Management for long-term partnership & to develop synergetic collaborations in resource sharing and knowledge sharing activities in Tourism & Hospitality Industry.
2. Both the parties will engage in a series of activities to design and develop processes to facilitate training & placement and outreach programs for mutually identified goals.

Scope

1. Conducting guest lectures, seminars, and workshops on collaborative basis in alliance with hotel officials and of NIPS Hotel Management Faculty.
2. Industrial site tours can be arranged at the hotel for the NIPS Hotel Management me students to facilitate better understanding of the business in terms of layout, functionalities
3. NOVOTEL KOLKATA HOTELS AND RESIDENCES can provide internship by way of industrial Training based on College Curricullum and Casual Training based on particular day's requirement for the hotel.
4. NIPS Hotel Management can provide NOVOTEL KOLKATA HOTELS AND RESIDENCES with trained manpower as per the requirement of the hotel offereing placement opportunities for students of NIPS Hotel Management based on their merit and competence.

C: Modus Operandi

Both parties will provide support for effective implementation of the MOU within the institutional rules and procedures

1. This MOU shall be effective from the date it is signed by both the parties
2. Within the broad framework of the MOU any financial commitment for joint activities shall be subject to the approval of the apprpriate authorities of respective organizations.

D: Obligations of the parties

1. The parties shall share knowledge and facilities within the institutional rules of each party to:
 - a. Actively participate in Food Festivals, other Promotional activities while providing necessary resources including access to archives, instruments, equipments and other facilities as mutually agreed
 - b. Share knowledge & information as necessary and feasible
 - c. No financial commitment from either organization shall be assumed unless a formal approval/acceptance to that effect has been accorded through signed documents by both paties

E: Duration and Termination

1. This MOU shall remain in force for a period of three years from the date of signing this agreement. However it may be automatically renewed for an extended period of two years unless any of the parties seek termination in writing.
2. This MOU may be terminated with at least three months notice given in writing and with the written consent of the signing authorities of the two organizations.



F: Data Sharing & Intellectual Property Rights

1. The Intellectual Property Rights in respect of joint projects will be decided on case to case basis.
2. Every member of both parties in any joint activities under the aegis of this MOU shall abide by the prevailing policies of the Govt. Of India with respect to classified information/data.

G: General Provisions

1. Neither party shall assign or in any manner transfer it's interests and agreed explicitly to that effect in writing. This MOU shall be binding on and inure to the benefit of the parties hereto and their respective heirs, representatives, successors and assignees.
